**Terms & Conditions**

1. The Firm will **Collect, Transport** and ensure subsequent **Treatment** of the **B.M.W.** within municipal limits of North Delhi Municipal Corporation as per the norms approved by Delhi Pollution Control Committee on the rates mutually agreed.
  2. **Bid Security:-** Contractor will have to furnish 2.5% Bid Security (Earnest Money Deposit-EMD) along with their bids in the form of Account Payee Demand Draft of Rs. 3750/- payable to Commissioner, North Delhi Municipal Corporation.
  3. **Performance Security :-** Contractor will have to furnish Performance Security Deposit @ 5% of Rs. 1.50 Lac approx., the estimated value of the work order in the form of Bank Guarantee amounting to Rs.7,500/-. This shall be pledged in the name of the Commissioner, North Delhi Municipal Corporation.
  4. When the contract ceases, the pledge will be cancelled and security will be returned to the Contractor. The security shall stand forfeited in the event of breach of any of the terms of contract.
  5. **Arbitration :-** All disputes relating to Rate Contract shall be subject to the territorial jurisdiction of Delhi Courts only.
  6. In the event of furnishing wrong information and false documents, appropriate authority in Govt. of NCT of Delhi shall be approached for appropriate action under relevant clause(4) of agreement with GNCTD.
  7. More Dispensaries/Maternity Homes etc. may be **added** to the list, if required.
  8. The Contractor, will provide the services on **Daily Basis** except on Sundays/National Holidays as under no condition the BMW should be allowed to be stored **beyond 48 hours**.
  9. There is provision of stringent action & Penalty against any default as BMW Mgmt. is a very important issue. Regular & efficient service is mandatory. North-DMC will have the right to **engage alternative Firm** in case of default.
  10. The Health facility will supply colour coded degradable plastic bags for packing the segregated Bio Medical Waste.
  11. A record of the services provided will be kept at each health facility and the service provider will get a certificate of regular, satisfactory and efficient services from M.O. I/C of each health facility before the monthly payment is released.
  12. If the contractor defaults on any of the terms and conditions of the agreement the Corporation may in spite of previous waiver and in spite of any penalty imposed on the contractor, forfeit the whole or a part of security deposited by the contractor for unsatisfactory performance of the terms and conditions of the agreement. The decision of the Medical Superintendent Mrs. G.L.Mty. Hospital, NDMC, shall be final and shall be binding on the Contractor.
  13. The contract period will be one year further extendable for 2<sup>nd</sup> year on the condition that the services are quite satisfactory.
  14. The contract can be revoked or cancelled at the discretion of the Medical Superintendent Mrs. G.L.Mty. Hospital NDMC at any time on the expiry of a **notice of 48 hours** to that effect.
