NOTICE INVITING EXPRESSION OF INTEREST

1. Expression of Interest (EOI) are invited on behalf of the Commissioner, South Delhi Municipal Corporation(SDMC) from eligible Resident Welfare Association (RWA) of the pockets A, B-1, B-2, C and D, DDA FLATS LOK NAYAK PURAM, BAKKARWALA, DELHI -110041 and Registered Society (RS) /Non Government Organization (NGO) working in the West Zone for the following works:

Name of work:- **SWEEPING OF DDA FLATS LOK NAYAK PURAM BAKKARWALA, DELHI -110041, UNDER PUBLIC PRIVATE PARTNERSHIP SCHEME IN POCKETS A, B-1, B-2, C and D.**

DURATION OF THE CONTRACT PERIOD – 3 YEARS.

2. The contract conditions along with forms for proposal submission and details of documents required (Proposal Documents) will be issued to the RWA of above mentioned pockets of LOK NAYAK PURAM and the RS/NGO working in the West Zone of SDMC by paying Rupees 500/- by Pay Order / Bank Draft in favor of the COMMISSIONER, South Delhi Municipal Corporation, from the Office of Executive Engineer(EMS), Room No. 1, Opp. Bindra Park, Rajouri Garden, New Delhi-110027 between 11AM & 4PM every day except Saturday, Sunday & public holidays, on or before 15/10/2013; by making a request on the Letter Head of the RWA / RS / NGO by the Authorized signatory.

The RWARS/NGO who meet the Pre-Qualification Criteria are requested to submit their "Expression of Interest" on their letter-head with all documents in support of their Pre-Qualification duly signed on each page by the Authorized signatory. The eligible RWARS/NGO will be shortlisted for issue of the detailed Request for Proposal.
4. **The RWARS/NGO are requested not to submit their financial bid at this stage and will not be considered.**
5. Separate EOI for each of above mentioned pockets A, B-1, B-2, C and D have to be submitted.
6. Criteria of eligibility, conditions of agreement, etc. will be as per details in the proposal document.
7. The detailed scope of work:- Carrying out Sweeping work, sanitizing, cleaning of street roads, drains, storm water manholes, gully gratings, bell mouth with pipe, foot path and other components related to sanitation work, the depositing the silt and sweeping material to nearest dhalao including material required like jhadu, lime, belcha, phawda, kolchi, wheel barrow etc which are under the governance of SDMC all complete in,

 - 7.4 Pocket C, DDA flats Lok Nayak Puram Bakkarwala, Delhi-41.
 - 7.5 Pocket D, DDA flats Lok Nayak Puram Bakkarwala, Delhi-41.

8. Rajouri Garden, New Delhi-110027 between 11 AM & 4 PM except Saturday, Sunday & public holidays. Receipt of EOI will be closed at 3 PM on 21/10/2013.

9. The period of contract shall be three years from the stipulated date of commencement as provided in letter of acceptance.

10. The sealed EOI shall be opened & evaluated by SDMC for short listing the firm on the basis of eligibility criteria prescribed in the contract document. The decision of the Corporation in this regard shall be final.

11. The RWARS/NGO shall have to submit performance security as per the proposal document before signing of agreement.

12. This notice inviting EOI, Contract document issued by the department and the EOI along with all documents submitted shall form part of the Contract.

13. No deviation shall be acceptable and will be summarily rejected.

14. The SDMC reserves the rights, without any obligation or liability to accept or reject any or all EOIs at any stage of the process, to cancel or modify the process or any part thereof or to vary any of the terms and conditions at any time without assigning any reason thereof.
