Since the EDMC follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of Govt. of India shall be applicable mutatis mutandis to the officer on deputation basis in East Delhi Municipal Corporation Further, the maximum age limit for appointment by deputation shall be not exceeding 56 years as on closing date of receipt of application.

3.The above said requirements of RRs are to be supplemented by the normal terms and conditions prescribed by the Govt. of India DoPT's guidelines & instructions for such appointments such as clearance from Departmental proceedings /civillai criminal proceedings, qualified performance assessment report, certified integrity etc.

4.
