

Subject: Revision of rates of Standard Licence Fee for East Delhi Municipal Corporation residential accommodation situated at New Usmanpur Colony.

The Directorate of Estates, Ministry of Urban Development, Govt. of India vide Office Memorandum No. 18011/2/2015-Pol.III dated 19.07.2017 has revised the rates of licence fee in respect of residential accommodations available in General Pool in terms of SR-324(4). SLF is revised/re-fixed after every three years which is based on the living area & category/type of flat and the rates are circulated by Govt. of India, MOUD (Directorate of Estates), the same are adopted in toto.

The enclosed revised rates of Standard Licence Fee are effective from 1st July, 2017 and as such, all the HODs/DCs/DDOs are requested to circulate this information amongst their respective officers/officials who are allottees of Mpl. Staff Quarters and take action to recover the revised licence fee/arrear of licence fee w.e.f. 01.07.2017 in accordance with the above mentioned office Memorandum. The revised rates of Standard Licence Fee can be seen on the East DMC's website- www.mcdonline.gov.in.


