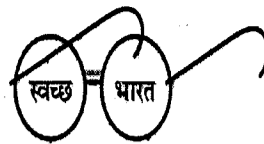

OFFICE ORDER

In pursuance of the recommendation of Union Public Service Commission, on the basis of CMSE-2015 and consequent upon the acceptance of offer of appointment by the candidate issued by Health Department, EDMC vide letter No. AO/CED/EDMC/HC (M)/2016/664 dated 10.10.2016, Commissioner/East DMC, vide his order dated 28.02.2017, is pleased to appoint Dr. Amit Kumar S/o Late Sh. Ashok Kumar Gupta, Roll No. 11115, Rank No. 832, Category-OBC, CMSE-2015, in East Delhi Municipal Corporation, to the post of General Duty Medical Officer, Grade-II and pay is fixed at the minimum of first cell at Rs. 56,100/- in level 10 of the Pay Matrix under 7th CPC (Corresponding to pre-revised scale in PB-3 Rs. 15600-39100 + GP Rs. 5400/-) plus NPA and other admissible allowances as per rules, on probation for a period of two years, subject to following conditions:-

2. Dr. Amit Kumar S/o Late Sh. Ashok Kumar Gupta, is being appointed after having been found medically fit by the Medical Board of SDN Hospital, East DMC.
3. The appointment is being made after the verification of character and antecedents of Dr. Amit Kumar S/o Late Sh. Ashok Kumar Gupta, from the concerned police authorities.
4. The appointment is subject to the terms and conditions as contained in the offer of appointment made to Dr. Amit Kumar S/o Late Sh. Ashok Kumar Gupta, vide letter No. AO/CED/EDMC/HC (M)/2016/664 dated 10.10.2016.
