In pursuance of the recommendation of Union Public Service Commission, on the basis of CMSE-2015 and consequent upon the acceptance of offer of appointment by the candidate issued by Central Establishment Department, SDMC vide letter No. AO/CED/SDMC/Supdt-IV/2016/1602 dated 07.09.2016, Commissioner/East DMC, vide his order dated 02.02.2017, is pleased to appoint Dr. Ekta Prajapati W/o Dr. Rajeev Kumar, Roll No. 14418, Rank No. 919, in East Delhi Municipal Corporation, to the post of General Duty Medical Officer, Grade-II and pay is fixed at the minimum of first cell at Rs. 56,100/- in level 10 of the Pay Matrix under 7<sup>th</sup> CPC (Corresponding to pre-revised scale in PB-3 Rs. 15600-39100 + GP Rs. 5400/-) plus NPA and other admissible allowances as per rules, on probation for a period of two years, subject to following conditions:-

2. Dr. Ekta Prajapati W/o Dr. Rajeev Kumar, is being appointed after having been found medically fit by the Medical Board of SDN Hospital, East DMC.
3. The appointment is being made after the verification of character and antecedents of Dr. Ekta Prajapati W/o Dr. Rajeev Kumar, from the concerned police authorities.
