CORRIGENDUM

In continuation of this office letter order no. A.D (CSD)/EDMC/2014/D-344 dated 28.02.2014 vide which tender document was uploaded on the official website of MCD and bids were invited for the proposed NIT dated 26.03.2014 extended to 31.03.2014 at 01:00 PM for Housekeeping/Watch & Ward Services through MTS at Community Halls of EDMC. The replies of submitted queries in pre-bid meeting dated 10.03.2014 at 03:00 PM is given below:

S.No	CLAUSE	QUERIERS	EDMC REPLY
1.	Volume 1 Clause (A)	An experience of Five years of similar works as indicated in the table of the tender is asked for. In this regards, it is mentioned that the tender being of service sector, in Delhi government Tenders, the experience asked is three years only. Moreover, the annual turn over for the last three years has been asked for in the present tender. Please rectify this clause.	As specified in terms & conditions
2.	Volume 1 Clause (L)	Documents to be attached with the bid document for short listing of technically qualified bidders: Under this clause, valid character from DM / DC / SSP for the proprietor or for all members, if partnership, has been asked for. This condition appears to be not desirable and unconvincing and normally such a condition in a tender is not put. In this place, the requirement of a license under private Security Agencies (Regulation) Act, 2005 would be more relevant and should be made mandatory. The Private Security Services / Watch & Ward is governed by this Act in the State. The license under the provisions of this Act is granted only after verifying the character / credentials of the proprietor / all the partners of a company through the District Authorities / Police. So, the condition of license under PSAR Act 2005 should be made mandatory and replaced with the present one.	As specified in terms & conditions
3.	Volume 1 Clause (M) Sub clause (I to iv)	The definition of joint Venture / Consortium / Partnership should be made more elaborate as under :- (a) The Joint Venture / Consortium / Partnership should be a legal entity incorporate as a company registered under the Indian Companies Act, 1956. Valid documentary proof of the same should be submitted in Technical Bid. In case of Joint Venture, any of the members of Joint Venture or JV itself should have requisite valid qualifying certificates. (b) Joint Venture Agreement / MOU shall be provided, in case the Bidder comprises of Joint Venture / Consortium Partnership firm duly in existence / registered at the time of applying / submitting the documents for this very tender.	As specified in terms & conditions
