1. That the Company have submitted the certify copy of the following documents as below:-
  1. Latest registration Certificate of VAT/TIN.
  2. Copy of the PAN of the company.
  3. Copy of Valid Drug License.
  4. Copy of the GMP Certificate.
  5. Latest Income Tax Return.
2. That the rate should be quoted both in words and figures, overwriting, alterations or cutting should be avoided and if any should be attested. All pages should be numbered and signed by the authorized signatory of the firm. The quotation given must be un-conditional.
3. That the Director(Ayush) reserves the rights to reject all quotation without assigning any reason(s) thereof.
4. That the Payment will be made on raising of bill after supply the medicines.
5. That the supplies are made within the delivery period of 04 weeks (28 days) from the date of dispatch of supply orders or receipt.
6. That If the firm fails to supply the required orders within the stipulated period an extension of one week can be granted on request with valid reasons by competent authority, thereafter a penalty @ 1% per week (Maximum 5%) will be levied till the full supply is given.
7. That on Failure to supply within the stipulated period will amount to cancellation of supply order.
8. That the company or its authorised person shall be responsible for safe supply of Medicines/Items to the store of the Ayush department/EDMC.
09. That the Ayush EDMC shall not be held liable for any loss of material in transit of late supply.
10. That the Medicines supply should be packed in standard govt. approved packing material.
11. That it is understood that the Department will take all efforts for timely release of payments. And no interest shall be paid in case of delay in payments if any.

13. That Under any circumstances, if the license of the supplier is cancelled or suspended during the supply period by any Govt. Authority(Central or State), such information should immediately be communicated to the department of Ayush/EDMC.
14. That each supply/packing, level, carton, envelopes etc should be marked **EDMC SUPPLY – NOT FOR SALE –in RED, Bold, CAPITAL LETTERS.**
15. That the company should provide sample in 02 nos of each product which is intended to be supplied or supplied alongwith Govt. approved Lab Test Report.
