

ADDEENDUM No. 1

**Sub:- Engagement of a contractor for toll and ECC collection at border points from
specified commercial vehicles entering Delhi:**

1.0 Following intending bidders attended the pre-bid meeting held 18-01-2016:

- i. M/s C.P. Rama Rao
- ii. M/s SS Multi Services
- iii. M/s Sahakar Global Ltd. JV
- iv. M/s Ayushajay Construction |Pvt. Ltd.
- v. M/s SMYR Consortium LLP
- vi. M/s DSC Engineering Pvt.
- vii. M/s Aryavrat Project and Developers Pvt. Ltd.
- viii. M/s MEP Infrastructure Developers Ltd

2.0 Pursuant to Pre-bid meeting and various queries raised by the bidders, following changes are hereby made to the RFP / Tender documents for Toll / ECC collection tender. These changes thus made shall be read at all the relevant clauses as a part of the Tender documents:

- a. The service Tax, if any payable, is to be paid by the Contractor.
- b. Bank Guarantee of Rs.5.00 Crores (Rupees five Crores) forming part of the EMD shall be valid for 120 days instead of 70 weeks.
- c. The successful Bidder shall be required to submit Performance Guarantee (after issue of LOI) totalling to Rs.44.00 Crores (Rupees forty Crores only) as under:
 - i) Rs.9.00 Crores (Rupees Nine Crores only) – Already deposited as EMD shall be converted as part of performance guarantee. However, the validity of the Bank Guarantee of Rs.5.00 Crores (Rupees five Crores only) deposited as part of EMD shall be extended to 70 weeks.
 - ii).Rs.35 Crores (Rupees Thirty Five Crores) in the form of Bank Guarantee valid for 70 weeks.
- d. No separate service charge is payable to the contractor for collection of ECC. The quoted toll bid amount of the bidder is expected to account for toll collection charges as well as ECC collection charges.
- e. In view of directions of the Hon'ble Supreme Court of India, the tendering process has to be completed in a time bound manner. Therefore no further relaxation on any other RFP condition is contemplated.

This is issued with the approval of competent authority and shall form the part of the Contract Document as Addendum No. 1.
