Health Department used to fix Rate Contract and Agency for the purchase of drugs, surgical supplies, lab chemicals, X-Ray items, general items and medical gases etc. under various Groups for the institutions under Health Department/EDMC on biennial basis. The previous Rate Contract and Agency was for the years 2015-2017. Though the process for fixing Rate Contract and Agency for the year 2017-2019 was started in December 2016, due to various reasons and apprehension of firms in participating in bids due to the proposed roll out of G.S.T., we could not make much progress in this regard. As the fixation of rate contract and agency for approx. 1700 items is very lengthy process, it may not be possible to finalize the same during current financial year i.e. before 31.03.2018. As is evident from the statement placed opposite showing the process flow from floating of tender to notification of final rates, considerable time and effort is required in finalization of the tender. The rate contract & agency for the years 2015-17 could be finalized between July 2016 to September, 2016 only though the process was started during October, 2014, which means, the biennial contract for 2015-17 could be made operational for barely one year.

With regard to query of Commissioner in another file regarding delay in initiating the process in time, it is submitted that proposal for Rate Contract & Agency for the years 2017-2019 was started in December, 2016. It is also submitted that after notification of the Rates & Agency with the approval of Corporation, contract agreements were to be signed with the firms and immediately after finalization of the RCA for 2015-17 the process for fresh RCA for years 2017-19 was started. It is worth to mention here that under similar circumstances, North DML has invited tenders for fixing RCA for years 2018-20 (copy of press advertisement placed opposite).
