Sub:- Fixing of Rate Contract and agency for the purchase of drugs, surgical supplies, lab chemicals, X-Ray items, general items and medical gases etc. under various groups for the institutions under Health Department of East Delhi Municipal Corporation on biennial basis for the year 2018-20 - representations of the firms regarding failure to quote rates in respect of item no.-V/186.

In the pre-bid meeting dated 16.03.2017, M.s. Eli Lilly and Company(India) Pvt. Ltd raised an issue regarding missing specifications of item no. V/186 in tender no. 15568 of NIT No.-Addl. DHA(M&TB)/EDMC/2017/115 dated 03.03.2017. It was decided that the specifications of item in question are Insulin-Dulaglutide 1.5mg with pack size of 0.5ml dispo-pan and the same was uploaded on the website as an addendum vide letter no. Addl. DHA(M&TB)/EDMC/2017/187 dated 27.04.2017.

Now M.s. Shri Ram Medical & Departmental Store and M.s. Eli Lilly and Company (India) Pvt Ltd. through E-mail (copies placed opposite) have represented that the specification of the item is still missing and there is no option for putting the rate.

The facts have been checked from the website. Though the specifications of item no. V 186 are available in the addendum dated 27.04.2017 but in the absence of SOQ/BOQ w.r.t. the item in question, the desirous firms can not quote the rates for the said item.

As per terms of NIT, the firms are required to quote the rates online only. However, under the circumstances detailed above, it is proposed that the firms willing to quote the rates of item no. V/186(Insulin-Dulaglutide 1.5mg with pack size of 0.5ml dispo-pan) may be allowed to furnish the rates of the said item with the manual bid in a sealed envelope.

If agreed, draft of the corrigendum to be uploaded on the website is placed opposite for approval please.
