OBC certificate will be considered only if issued from GNCTD. One Passport size photograph is also to be submitted. Candidates who have done graduation from foreign universities must also submit their score of FMIGE/ National Board of Examination screening examination. The eligibility will be as per standard norms included for age. The cut off age will be decided on the basis of as on 01.10.2015.

Requisite qualification:- MBBS

Incomplete application will not be considered. 3% post are reserved for PwD as per the guidelines of Govt. of India.
