Item no. 92 Revision of Recruitment Regulations for the post of Supervisor (Audit) on the basis of notified R. Rs. for the post of Supervisor (Audit) of India Audit & Accounts Departments.

I. PROPOSAL

The Recruitment Regulations for the post of Supervisor (Audit) of this office were first time framed in 2014 and were approved by the North Delhi Municipal Corporation vide Resolution No. 91 dated 07.07.2014, South Delhi Municipal Corporation vide Resolution No. 141 dated 12.10.2015 and East Delhi Municipal Corporation vide Resolution dated 24.06.2015 respectively. The above approved Recruitment Regulations were sent to the Secretary (UD) and Director of Local Bodies, Govt. of NCT of Delhi for approval before these R.Rs. are sent to the UPSC for its concurrence and further notification of R.Rs. in the Delhi Gazette. These Recruitment Regulations were returned by the Director of Local Bodies to this office for uploading the proposed Recruitment Regulations in the website of this office for seeking objections/suggestions in public domain relating to all concerned, submitting the R.Rs. proposal in the prescribed check lists/requisite annexure and also make necessary amendments in the scale of pay of this post as per the 7<sup>th</sup> CPC. After the return of these Recruitment Regulations by the Director of Local Bodies to this office to comply with the above observations, a representation from one Senior Auditor of this office was received from the Office of the Chairman, Standing Committee and also from the Leader of Opposition, North Delhi Municipal Corporation requesting therein to amend the Recruitment Regulations for the post of Supervisor (Audit) on the basis of notified Recruitment Regulations of Indian Audit & Accounts Department. The above representation has been considered and the necessary amendment in the Recruitment Regulations for the post of Supervisor (Audit) of this office have been made as per the notified Recruitment Regulations of Indian Audit & Accounts Department, 2001. Besides this, necessary amendments as suggested by the Director of Local Bodies, Govt. of NCT of Delhi have also been made in the Recruitment Regulations for the post of Supervisor (Audit) of this office.

As per the allocation of posts made by the Secretary (UD) and Director of Local Bodies, Govt. of NCT of Delhi vide order No. F.No. PS/Secy./JD/2012/Pt.-I/491-97 dated 18.04.2012, the posts of Supervisor (Audit) for North, South & East Delhi Municipal Corporations are 02, 02 and 01 respectively. After the proposed amended Recruitment Regulations are approved by the Corporation, these Recruitment Regulations will be uploaded in the website of this office for seeking objections/suggestions in public domain relating to all concerned before these are sent to the Secretary (UD)/Director of Local Bodies, Govt. of NCT of Delhi for approval and their notification in the Delhi Gazette.

## **II. RECOMMENDATION:**

The office of the Chief Auditor is functioning as a combined Audit Office for North, South and East Delhi Municipal Corporations. Therefore, the East Delhi Municipal Corporation through the Standing Committee of East Delhi Municipal Corporation is requested to approve the Recruitment Regulations for 01 post of Supervisor (Audit) for East Delhi Municipal Corporation as contained in Annexure.

**ANNEXURE**

**1 SHORT TITLE AND COMMENCEMENT:**

- (i) These Regulations may be called the North, South & East Delhi Municipal Corporations, Statutory Audit Department Supervisor (Audit) Recruitment Regulations, 2017.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

**2 NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY:**

The number of the said posts, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these Regulations.

**3 METHOD OF RECRUITMENT, AGE LIMIT, QUALIFICATION ETC.:**

The method of recruitment to the said post, age limit, qualification and other matters relating thereto shall be as specified in columns 5 to 14 of the aforesaid Schedule.

**4 DISQUALIFICATION:**

No person—

- (a) who has entered into or contracted a marriage with a spouse living;  
or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person;

shall be eligible for appointment to the said post, provided that a North, South & East Delhi Municipal Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Regulation.

**5 POWER TO RELAX:**

Where a Corporation is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these Regulations with respect to any class or category of persons.

**6 SAVING:**

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons, in accordance with the orders issued by the Government of India from time to time in this regard as applicable to persons in the Office of the Chief Auditor of a Corporation.
