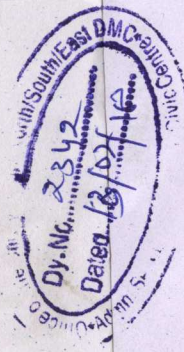

**Subject :—** Revision of Recruitment Regulations for the post of Assistant Audit Officer in the Office of the Chief Auditor, North/South/East Delhi Municipal Corporations.

**(i) Municipal Chief Auditor's letter No. MCA/Admn./RR-AAO/2-22/750 dated 23-11-2017.**

The Recruitment Regulations for the post of Assistant Audit Officer in the Statutory Audit Department, MCD were approved by the unified Corporation vide Resolution No. 287 dated 25-8-2003 and were sent to GNCT of Delhi for notification in the Delhi Gazette vide this office letter No. MCA/Admn./RR-AAO/40 dated 5-5-2004 but has not been notified in the Delhi Gazette so far. Consequently upon revision of pay scales w.e.f. 1-1-2006, the merger of the posts of Section Officer (Audit) & Assistant Audit Officer and redesignation of post of Section Officer (Audit) as Assistant Audit Officer as approved by the Corporation vide Resolution No. 780 dated 15-2-2010 and change in the number of sanctioned posts of Assistant Audit Officer on 18-4-2012 vide Order issued by the Secretary (UD) and Director of Local Bodies, Govt. of NCT of Delhi vide No. F. No. PS/Secy./UD/2012/Pl./491-97 at the time of trifurcation of MCD from 49 to 61, these Rules were revised and the revised Recruitment Regulations were approved by the North, South & East Delhi Municipal Corporations vide Resolution No. 92 dated 7-7-2014, 142 dated 12-10-2015 and 27 dated 24-6-2015 respectively. After approval accorded by the North, South & East Delhi Municipal Corporations, these R.Rs. were sent to Secretary (UD) and Director of Local Bodies, Govt. of NCT of Delhi for approval and their notification. However, these R.Rs. were returned by the Director of Local Bodies to this office to upload the proposed Recruitment Rules in the website of MCD for seeking objections/suggestions in public domain relating to all concerned, submitting the R.Rs. proposal in the prescribed checklists/requisite Annexures and also make necessary amendments in the scale of pay of this post as per 7th CPC. Now, these Recruitment Rules have been reviewed and necessary amendments have been made due to revision of pay scale of the post of Assistant Audit Officer in Level-8 of Pay Matrix as per the 7th Central Pay Commission's recommendations which have been implemented in the North, South & East Delhi Municipal Corporations also. The revised Recruitment Regulations along with existing R.Rs. as approved by the North, South & East Delhi Municipal Corporations for the post of Assistant Audit Officer are given in Annexure. After approval of each Corporation, these revised R.Rs. will be uploaded in the official website of MCD for seeking objections/suggestions in public domain relating to all concerned and thereafter will be sent to the Govt. of National Capital Territory of Delhi, for approval and notification in the Delhi Gazette as required in term of Section 98(2) of the DMC Act, 1957. The post of Assistant Audit Officer falls under Category 'B'.

## II. RECOMMENDATION :

The office of the Chief Auditor is functioning as a combined Audit Office for North, South and East Delhi Municipal Corporations. Therefore, the North Delhi Municipal Corporation is requested through the Standing Committee of North Delhi Municipal Corporation to approve the revised Recruitment Regulations for 23 posts of Assistant Audit Officer as contained in the Annexure.
