CORRIGENDUM

In continuation to NIT No. ADC/RP Cell/2018/D-131 dated 23.05.2018 and consequent corrigendums No.ADC/RP Cell/NDMC/2018/D-435 dated 20.07.2018 and No.ADC/RP Cell/NDMC/2018/D-437 dated 23.07.2018 for e-auction for regular allotment of 64 authorized parking sites and temporary allotment of 1 Parking site falling under the jurisdiction of North DMC on payment of advance monthly license fee basis, clause 1.b(i) of the terms and conditions under the head Experience may be read as under: -

b. Experience:

- (i) For category A, B, C, D, E & F the bidder must have experience of running/managing parking sites for at least one year as on the starting date of registration. However, **for category 'F' i.e., upto 2 lac, no experience is required for unemployed graduate bidders.** The turnover of the bidder from the parking business should be at least equal to the amount of three times of the Minimum Reserve Price (i.e., 3 times of MRP) of the parking site for which the bidder applies for registration for e-auction bid. In case the bidder applies for more than one parking site then the turnover would be decided by the formula 3 X gross total of MRP of each parking site applied. The partnership firm/ public limited company/firm/private limited company/ firm/which has changed their Members/ Directors during the last one year and who or the company/firm in which he or she being a member or office bearer has defaulted on payments of the Central/State Govt./PSUs of Central & State Govt./Local Bodies including North, South & East DMC or got blacklisted, shall not be eligible for participation in NIT.

Further, clause 4(d) of terms and conditions under the clause Earnest Money/Security Deposit/Bank Guarantee/Monthly License Fee may be read as under: -

- (d) **A Bank Guarantee or Fixed Deposit** in the name of Commissioner, North DMC by a scheduled/Nationalized Bank of the amount equivalent to the 3 (three) times of the quoted monthly License Fee (MLF) valid for the entire period of the license agreement plus six months thereafter has to be made within 7 days of issue of the Letter of Intent.
