North Delhi Municipal Corporation ("North DMC") invites responses from eligible business entities in the form of proposal ("Proposal") in accordance with Request for Proposal ("RFP") Document, in order to identify suitable entity (the "Developer") through an open, transparent and competitive bidding process for "Development of Multilevel Parking at Idgah Road, Delhi on Public Private Partnership Basis in City - S. P. Zone" by allotting commercial space on Lease basis. North DMC intends to follow two bid bidding process for selection of the Developer for the Project.

Bid Validity Period (From opening of financial bid)

The Developer shall be responsible for design, engineering, financing, procuring, constructing, operating and maintaining the Project in accordance with the Concession/Lease agreement to be entered into between the North DMC and Lessee. The Developer shall operate and maintain the parking facility for the prescribed period of 5 years as per the Concession Agreement. The Developer would get rights to collect (a) the parking fees and other rentals as per the Concession/Lease Agreement (b) market commercial facilities and recover investment in terms of the Concession/Lease Agreement. The commercial area shall be Leased out to the lessee for the prescribed period of 99 year as per the Lease Agreement.

The bidders are required to be registered on e-tendering portal of North DMC for submitting the financial proposal in case they are not registered earlier.
