1. If after opening the Bidder withdraws his bid during the period of Bid Validity Specified in Form of Bid.
2. If the Bidder having been notified to the acceptance of his bid by the Employer during the period of Bid Validity.
 - a) Fails or refuses to execute the Form of Agreement in accordance with the Instruction to Bidder, if required; or
 - b) Fails or refuses to accept the receiving of letter of acceptance or work order; or
 - c) Does not accept the correction of the Bid Price pursuant to tender conditions.

OR

We undertake to pay the Employer up to the above amount upon receipt of this written demand without the Employer having to substantiate his demand, provided that in his demand the Employer will note that the amount claimed by him is due to him to the occurrence of one or any of the three conditions, specifying the occurred condition or conditions.

The Guarantee will remain in force up to and including the date ** days after the deadlines for submission of Bids as such deadline is stated in the Instructions to Bidders or as it may be executed by the Employer, notice of which extension(s) to the Bank is hereby waived. Any demand in respect of this guarantee should reach the Bank not later than the above date.
