#### ELIGIBILITY CRITERIA

1. The bidders who are in business of fabrication of vehicles /Automobile body fabrication /manufacturers of vehicles at least for the last three years are eligible to participate in the tendering. The bidders should have executed at least one work of fabrication of vehicles with installation of hydraulic lift for an amount not less than 80% of the estimated cost of fabrication i.e. Rs.28 lakhs excluding taxes in any year or two works for an amount of not less than 60% of the estimated cost of fabrication i.e. Rs.21 lakh excluding taxes or 3 works for an amount not less than 40% of the estimated cost of fabrication i.e. Rs.14 excluding taxes lakhs in any one year during the last three years i.e. 2016-17, 2017-18 and 2018-19.
2. The applicant should have Average annual financial turnover of not less Rs. 18,00,000/- (Rupees Eighteen lakhs only) during the last three financial years ending 31st March, 2019. A certificate from Chartered Accountant should be enclosed as per **Annexure "A"**.

#### SUBMISSION OF BIDS

The Bidder would provide all the information as per the tender document. North Delhi Municipal Corporation would evaluate only those bids which are completed in all respects. The bidders will submit their bids in two parts i.e. Technical bids and financial bid (Price Bid). Each Proposal shall comprise the following:

##### A. Submission of Technical Bid in Envelop 'A'
