S. No.	Queries	Clarification
1	The last date of Bid submission should be extended till the end of 3 rd lockdown period due to the pandemic of Covid-19 across the country.	The time has already been extended two times earlier, as the offices are opened now, there will be no further Extension of time.
2	Regarding EMD, it should be exempted for MSME/NSIC registered firm.	It will not be exempted as per the prevailing guidelines.
3	Regarding BOQ, it was informed that the same is incorrect, because the Bidders are unable to fill the rates in it.	Rates are to be filled online
4	It was suggested by the Bidders that, in Annexure -III column 7 & Annexure -IV S. No. 13 the, requirement of GOI License (DGR Registration) should be removed and it should be changed to, that, the firm should have its own training institute or tie-up with the training institute registered under PSARA Delhi Govt for imparting training to the security personnel.	Tender conditions will prevail and there will be no change in respect to this query.
5	Regarding Annexure -IV column 3, undertaking on a stamp paper of Rs. 100 as per Annexure VII is not available in the NIT. It is on Annexure -5 in the NIT.	In Annexure -IV column 3, Annexure VII be read as Annexure -V in the Tender document.
6	Regarding Physical submission of Bid, it should be submitted online only because it is e-tender.	The query is not specific, the tender conditions will prevail.
7	Regarding price-bid (Annexure-IX), Minimum wages as applicable as on 01/04/2019 mentioned in table-2, S. No. 1 of Price Bid may be changed as on current date.	Tender conditions will prevail and there will be no change for the query.
8	Regarding price-bid (Annexure- IX), Service Charges in Table-3 of Price Bid should be fixed not less than minimum 4%.	Tender conditions will prevail and there will be no change for the query.
