CORRIGENDUM

In continuation of Auction Notice uploaded on the MCD Website for allotment of vacant parking sites of North Delhi Municipal Corporation on 21.10.2015 to the highest bidders on temporary basis on payment of Advance Monthly License fee for three months extendable upto next three months, the following amendment have been made in the list of proposed parking sites to be auctioned.

1. The Minimum Reserve Price for parking site at MLUG Model Town-II (Sl No. 1) may be read as Rs. 108000/- instead of 180000/-
2. The vehicle allowed for parking site at Coat Market, Jama Masjid (Sl. N. 14) be read as Bus/Tempo/Car Two Wheeler instead of Car/Two Wheeler. And DD of Rs. 1,00,000/- is to be deposited for participation in the auction instead of Rs. 2,00,000/-
3. In terms & conditions at Sl. No. 1 (e) may be read as "He must also give balance sheet, as applicable, for last three years as the case may be prior two days of the date of auction i.e., 19.10.2015 instead of three days of the date of auction i.e., 09.10.2015.
