**TERMS AND CONDITIONS FOR ITEM NO.-1**

The following conditions shall also apply

1. The offer should be valid for minimum 120 days from the opening of price bid.
2. The work is to be executed within prescribed period.
3. The rates should be quoted by the bidders, mentioning inclusive OR exclusive of Taxes etc. clearly in the online proforma of details of taxes.
4. No post modifications on tax/ Govt. Levy will be allowed/ accepted.

5. The Contract Agreement is to be executed with Department and necessary terms & conditions of the Department are also to be signed by the lowest offered within 3 days on a non-judicial stamp paper of Rs.50/-.
  6. The job/supply will be guaranteed for 6 months from date of completion.
  7. The contractor will bear the penalty @1% per week of the cost of the tender, if fails to arrange the supply/repair of machines/vehicles within stipulated period w.e.f. the date of the receipt of the purchase order/receipt of machines/vehicles from the department. The penalty may be imposed upto 5% of the tender cost.
  8. The payment will be released after completion of work.
  9. Action will be taken against the firm/company/contractor if the work is not completed within the stipulated period. All deposits of the contractor with the Department will be forfeited pertaining to work as per clause No. 7 above.
  10. The tender fee will not be reimbursed for any expensed incurred in preparation or submission of tender or for any other reason for the period it remains within the Department.
  11. The Bill of Quantity cum Schedule of Quantity, specifications, terms and conditions of the tender will not be used by tenderer for any other purpose and will not be given to any other contractor of department or for any other use to any body or agency.
  12. The Department (North DMC) reserves the right of reject any of or all the tenders without assigning any reason.
  13. The department (North DMC) decision will be final and binding in case of incomplete tenders, cuttings or over writings. Such binding even up to the final stage of the contract.
  14. All disputes are subject of Delhi Jurisdiction only.
  15. No conditional tender will be accepted in any way. Tenderers with any conditions including conditional rebate shall be rejected out rightly however tenders with unconditional rebate will be acceptable. No post modifications of tenders will be allowed /accepted in any way/kind.
  16. In force measure conditions the decision of the Department shall be final and binding.
  17. Any type of damage of Govt. / Private properties, accident with the equipment of staff on duty or any person will be borne by the contractor.
  18. Any accident during or up to completion of work will be on contractor's part and department will not in any way compensating for anything.
  19. The contractor will take the equipment for repair in consultation with Engineer-in-Charge of site.
  20. The contractors have to submit the solvency certificate for @40% of the estimate of the work.
  21. The company/firm/contractor has to submit the details of bank account i.e. a. Bank's Name b. Branch name c. Account Number c. IFSC code e. MICR etc..
  22. The contractors have to submit the copy of the GST Regn. And return of I/Tax for AY 2016-17 resp., which is mandatory & part of Technical Bid Stage-1.
  23. The contractors have to submit the PAN of his/her firm, in case of showing individual PAN, the contractors have to submit an affidavit stating that he/she is the proprietor of the firm and responsible for filing all taxes liabilities in time, which is mandatory & part of Technical Bid Stage-1.
  24. Only Manufacturers and their authorized workshops or reputed workshops are eligible, who have dealt in Fabrication of Heavy motor vehicles satisfactorily in the last 7 years of the following qualification criteria, mandatory & part of Technical Bid for the tender, as under:--

- (i) Three similar works, each of value not less than 40% of the estimated cost put to tender, Or
- (ii) Two similar works, each of value not less than 60% (Modified as per OM/CON/261) of the estimated cost, Or
- (iii) One similar work of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited.

#### **TERMS AND CONDITIONS FOR ITEM NO.-2 & 3**

**The following general terms & conditions shall also apply: -**

1. The offer should be valid for minimum 120 days from the opening of price bid.
2. The work is to be executed within prescribed period.
3. The price quoted by the tenderer shall be firm and F.O.R. site, net and inclusive of excise duty, octroi, transit insurance, all taxes and all other Government levies. However, the rate of excise duty and sales tax as included at the time of tendering must be clearly indicated in the tender. The Govt. levies are prevailing at the time of delivery shall be payable.
4. The Contract Agreement is to be executed with Department and necessary terms & conditions of the Department are also to be signed by the lowest offered within 3 days on a non-judicial stamp paper of Rs.50/-.
5. The payment will be released after completion of supply i.e. satisfactorily supply of the machines. As far as payment of AMC is concerned, it will be released as per the AMC's terms and conditions.
