### Special conditions for submission of bids:

- The contractors/firms having experience of applying anti-carbonation paint on flyovers/grade separators/elevated corridors/viaduct with any of the central/state government departments or autonomous bodies shall be eligible to apply. The contractors/firms should have satisfactorily completed three works of applying anti-carbonation paint each costing not less than **Rs. 70.00 lacs** or two works each costing not less than **Rs. 105.00 lacs** or one work costing not less than **Rs. 140.00 lacs** during the last seven years ending last day of the month of December 2017.
- The intending bidders fulfilling the condition mentioned at S. No. 1 above who are not registered in any of the Municipal Corporations of Delhi, will be required to get the registration for MCD e-tendering system with the IT Department of North Delhi Municipal Corporation for online submission of financial bid.
- Self attested copies of certificate/s for satisfactory completion of work/s mentioned in S. No. 1 above shall be submitted by the contractor alongwith the earnest money in the same envelope that containing the DD/PO towards EMD.
- The financial bids of only those bidders shall be opened on due date who have submitted the certificates as mentioned in S. No. 3 above to the satisfaction of the Department.

**NOTE: In case of difference in system generated EMD and that given in "NOITCE" the EMD shown in Tender Notice will have to be deposited as EMD. Tender Cost (non-refundable) & EMD to be accepted in the form of D.D./P.O. in favour of Commissioner, North Delhi Municipal Corporation and their number should tally with the number mentioned online failing which bid is liable to be rejected.**

As per schedule the Executive Engineer (Pr.) City-S.P. Zone, on behalf of the Commissioner, North Delhi Municipal Corporation invites online percentage rates / Item Rates from the eligible contractors registered in any government department for the above mentioned work. The tender cost and the earnest money should be submitted online either through e-payment or through demand draft / pay order of a scheduled Bank in favour of Commissioner North Delhi Municipal Corporation. **THE TENDER COST/EMD SHOULD BE DEPOSITED ON OR BEFORE 19.01.2018 UPTO 15.00 HRS IN THE OFFICE OF S.E. (Pr.) City-S. P. Zone, 2<sup>ND</sup> FLOOR, NIGAM BHAWAN, KASHMERE GATE, DELHI-06.** The conditions as given in the printed NIT form A-32, Chapter-IV, Mpl. Accounts code, Part-I will also hold good. All the applicable taxes will be paid by the contractor. If the rates quoted by the lowest tender are found abnormally low, the payment to the contractor for the work shall only be made after inspection by Quality Control Cell at different stages and the findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by contractor. In case the lowest contractors fails to commence/ complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per provisions of the enlistment rule/ instruction issued from time to time. The testing of the works / supplies shall be got done in accordance of office circular No- CVOMig./05/2289 dt 17-5-05 and charges of test also be borne by the contractor accordingly. Circular No. E.E.-(P)-III/2005-06/D-398 dt 17-6-2005 is applicable. The cement /steel, if any, will be procured by the contractor as per terms & conditions of NIT. In case of holiday, the tenders will be sold/ issued/ received on the next working day.
