2	2.1.15 RFP document	The definition of Associate defined by SDMC is in violation of definition of Associate as per Companies Act. Definition of associates for this project shall be as per clause 2.1.15 of RFP document.
3	2.1.17 RFP document	Since long SDMC, MCD, North Delhi Municipal Corporation, used to have a policy to limit the number of zones that can be awarded to a single company to avoid risk of monopoly, strike etc. Similar policy is in place in Mumbai (MCGM) also. Would there be any such policy applicable in this tender?	The clause 2.1.17 of RFP document is for wider participation and healthy competition.
4	2.19.2 RFP document	This clause should be deleted as it pertains to previous tender terms when C&D waste, silt etc. were also part of scope of work.	Applicant/Bidders are advised to quote CTC after carefully evaluating scope of project and resources deployment.
5	2.20.1 RFP document	We request you to give a higher percentage to Diesel as admitted in the document as 15% for West Zone.	The clause 2.20.1(c) has been amended.
6	2.22 RFP document	These event charges will become too less due to inflation in 5-6 years. As such these should also increase with WPI/Inflation.	No change.
7	3.1.1(A) RFP document	As per CPWD Manual, experience of last 7 years only is considered. Please modify accordingly.	No change.
8	3.1.1(B) RFP document	Is bidder required to have experience in Storage i.e. Bins, Dhalaos etc.?	No change.
9	Note of 3.1 RFP document	There is no clause 2.1.7 as mentioned.	Clause 2.1.7 is mentioned in RFP document at page 15.
10	3.3(ii) RFP document	Is satisfactory work performance certificate required or bad performance certificate will also work? Also, can the certificate be one year old?	Please refer clause 3.3(ii) and 3.1.1(A & B) of RFP document.
11	3.3(vii) RFP document	Please provide Net Worth formula.	Please refer clauses 3.3 (vi) of RFP document.
12		Would the entities in losses be considered for qualification?	Please refer amended clauses 3.2.1 (ii).
13	4.2.4-1 RFP document	There is no clause 3.2.2 for Turnover. Please re-confirm.	In clauses 4.2.4-1 of RFP document, the clause 3.2.1 was mentioned for minimum turnover and it was mentioned in clause 2.1.6 that Combined Technical and Financial strength of all Consortium members shall be considered towards qualifying and evaluation criteria as prescribed in the Clause 3 and 4.
