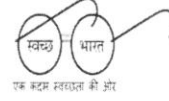

Some queries were raised during pre-bid meeting are replied as under:

S.N O.	QUERRY	REPLY
1.	Whether SDMC will select the bidders for empanelment only based on equipment specification.	As has been mentioned, The EOI has been floated for deriving best specification, Quality along with best price for offering through separate tender as per the requirement.
2.	Whether product price be given including 1 year warranty or with 3 year AMC simultaneously or separately.	The offer of price is made on the basis of price of Equipment with 1 Year warranty. Further, bidder has to assure availability of spare parts for at least next 5 years in case of garden implement mentioned at (A & B). In case of (C & D) there is no warranty. However, the product may be got checked by the third party to ascertain its quality parameters.

	QUERRY	REPLY
3.	Whether spare parts rates are to be given?	The rate of spare parts is given separately in proposal.
4.	Mention the quantity of equipments.	The quantity will depend on the actual requirement arising in zonal offices.
5.	Any other Machinery required.	Bidder is free to submit the product other than mentioned in the schedule.
6.	The offered price of equipments/machinery will be valid for how much period.	The offered price shall be valid for a period of one year. However, in the EOI document " Terms of Reference for the Manufacturer /Dealer/Distributor " point no.(i) may be read as :- "The best price offer obtain would be applicable for a period of one year, further the bidder has to submit undertaking regarding supply of spare parts on a regular basis/ as and when required for the next 5 years."
