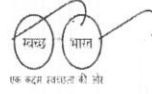

Some queries were raised in pre-bid meeting are also replied as under:

S.NO.	QUERY	REPLY
1.	Whether warranty clause will be applicable for miscellaneous items?	As has been mentioned the EOI document, the offer of price is made on the basis of price of Equipment with 1 year warranty. Further, bidder has to assure availability of spare part for at least net 5 years in case of garden implement mentioned at A & B. In case of C & D it is not applicable.
2.	Whether dealer or manufacturer will provide/submit the complete specifications of the product?	As has been mentioned in EOI document, the Dealer /Distributor/Manufacturer will have to submit detail specification for each product they are offering for empanelment. The manufacturer will submit their price offer only for the product for which they have submitted the specification and applicable valid BIS certificate/quality parameter.
3.	Whether the bidders will submit regarding company/brand of the product?	Yes
4.	When will the bidder specify their registered dealer during the process of EOI?	It is required during process of Tendering of items.
5.	What will be the criterion for specifications and rate of the product and its third party quality check?	The product may be got checked from Government labs or any other Govt. designated labs for quality assurance
6.	Whether time extension will be allowed for this E.O.I?	The time for submission of EOI has been extended till 08/09/2017 upto 03.00 P.M.

All other terms & conditions will remain the same.
