Some queries were raised in pre-bid meeting and are replied as under:

S.NO.	QUERY	REPLY
1.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The financial bids are to be submitted online at e-tender portal of SDMC only. However, the Technical Bids may be submitted online upto 6.11.2017 as well as manual till 08.11.2017 upto 03.00 P.M.
2.	Mandatory experience in similar works be relaxed / reduced.	The mandatory experience in similar works should be similar as already specified in the tender document.
3.	Minimum Average annual turnover be relaxed / reduced.	The annual average turnover should be at least Rs.80 lacs for the last three years.
4.	Submission of EMD be exempted.	The EMD of Rs.1,60,000/- be deposited in the specified form along-with Technical bids. However, the EMD of only successful L-1 bidder will be retained by the SDMC and EMD of unsuccessful bidders will be released immediately as has already been specified in the tender document.
