However we enclose Office Memorandum issued by Department of Personnel and Training (Welfare section) New Delhi bearing no. 14/1/2009 welfare dated 19/02/2015 wherein it is clearly mention that special dispensation to Kendriya Bhandar, NCCF and other Multi state Cooperative society shall not be extended beyond 31/03/2015 i.e. there shall be no dispensation to these organisation with effect from 01/04/2015. In this matter we request you to clarify eligibility of these entities.</p> <p>2. In terms of your tender terms and conditions clause 42 the supplier has to get goods insured at his own cost for goods supplied and stored at the designated store during the inspection and receipt of test report of the supplied goods. We wish to inform you that since the material is in your custody and premises, the Insurance company will not take on Insurance of the material in our name. In this matter we request you to clarify in the matter.</p> | <p>1. As per term and condition of tender, no special dispensation to Kendriya, NCCF, DCCWSL will be given. These types of organisations can take part in tender process as any other vendor.</p> <p>2. As per terms and conditions of tender, even the goods are stored in the designated premises, till such time the bidder shall keep the goods in his own custody, the department will take custody only after receipt of test report that goods supplied as per specifications.</p> |
