Open online tenders/RFP are invited on behalf of Commissioner, S.D.M.C. under two bid system i.e. Technical Bid and Financial Bid from experienced and financially sound manufacturing firms/Agencies/ authorized suppliers / dealers/ distributors / Contractors of Effluent Treatment Plant equipment through Dy. Director (Horticulture) HQ, SDMC, E-1 BLOCK 3<sup>rd</sup> Floor S.P.M. Civic Centre, New Delhi-110002 for the work of "SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF PREFABRICATED PORTABLE CONTAINER BASED EFFLUENT TREATMENT PLANTS HAVING CAPACITY 100 KLD, BASED ON MBBR (MOVING BED BIOREACTOR) TECHNOLOGY AT SEVEN DIFFERENT LOCATIONS UNDER THE JURISDICTION OF SOUTH DELHI MUNICIPAL CORPORATION" The tenders will be received as per above time table and Technical Bids will be opened on **04.01.2018 at 1530 Hours**. Bidder must be a reputed & experienced Contractor / manufacturing firm / authorized supplier / dealer / distributor of Effluent Treatment Equipments.
2. The registered contractors of MCD (SDMC/NSDM/EDMC) are also eligible to tender for the amount they are registered subject to the condition that they fulfil eligibility requirement in Technical Bid submission. For other contractor(s) / New bidders they may get themselves registered for tendering / bidding in SDMC. 4. SELECTION PROCESS A single stage, two-bid system (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance of each proposal as submitted by the Applicant, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having lowest financial bid may be considered for award of work.

6. **Tender cost of Rs.1000/- (Non refundable)** shall be made by way of Demand Draft/Bankers Cheque/ Pay order ONLY. The bid security (EMD) is **Rs.588000/-** (Rupees Five lacs eighty-eight thousand only) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order only. 8. **MANDATORY FINANCIAL TURNOVER** Average annual financial turnover on works should be at least **Rs.294.00 Lacs** during the immediate last three consecutive financial years. The bidder will submit turnover certificate from Registered Chartered Accountant.
9. **MANDATORY SOLVENCY CERTIFICATE:** Bidders will submit original Solvency certificate for a minimum amount equal to **Rs.117.60 Lacs** or more from a Nationalised/Scheduled bank in India. Solvency Certificate in original must be submitted along-with Technical Bid Documents. (photocopy of the solvency certificate shall not be entertained).
10. **MANDATORY EXPERIENCE IN SIMILAR WORK:** Bidder should have experience of successfully executing similar nature of work/s i.e. Three similar completed works costing not less than the amount equal to **Rs.117.60 Lacs** OR Two similar completed works costing not less than the amount equal to **Rs.176.40 Lacs** OR One similar completed work of aggregate cost not less than the amount equal to **Rs.235.20 Lacs** AND One completed work of any nature (either part of (a) or a separate one) costing not less than the amount equal to **Rs.117.60 Lacs** with some Central Government Department/ State Government Department/ Central Autonomous Body/ Central Public Sector undertaking/State Public Sector Undertaking/ City Development Authority/Municipal Corporation of City formed under any act by Central/State Government and published in Central/State Gazette. **Experience in similar work / jobs means "Supply / Commissioning of Effluent Treatment Plant/Sewerage Treatment Plant on MBBR Technology".**

(iii) Copy of Valid PAN Registration. (iv) Valid GST Registration. (v) Experience certificate issued from competent authority in respect of completed similar work & one government work. (vi) Financial Turnover Certificate duly certified by Registered C.A. (vii) The Company/Firm profile Detail of the firm/bidder whether participating as Partnership Firm OR Proprietor-ship Firm OR Individual Firm OR Private Limited Firm OR Limited Firm OR other please specify and submit. (viii) Acceptance of all Terms & Conditions of Tender (ix) Undertaking by the bidder that the Bidder or his firm has not been Blacklisted / Debarred / Banned anywhere in India by any Government Department / Government Undertaking. The said performance security shall be deposited within 15 days of issue of Letter of Intent / Acceptance from SDMC.
