Separate sealed tenders on item rates basis are invited for execution of the following work from the contractors of SDMC and will be received as per time table and will be opened on 16.01.18 at 3:30 P.M. on website <http://mcdetenders.com> after downloading the Tender by Ex. Engineer (A)-I, Auto Workshop, Dwarka, Sector-9, New Delhi in the presence of the contractors, if any.

Bidding documents are to be downloaded from the website <http://mcdetenders.com>.

Both tender cost and earnest money is to be paid through Net Banking or to be deposited in the form of Bank Draft of a schedule bank in favour of the Commissioner, SDMC. The desirous contractors shall have to pay the tender cost and earnest money mentioned against each. If the payment is made through Demand Draft, then the contractor has to deposit the different Demand Drafts for tender cost and earnest money at the time of close of bidding (upto 3:00 P.M.) and the same will be received in the room of Ex. Engineer (A)-I, Auto Workshop, Dwarka, Sector-9, New Delhi. The following conditions shall also apply: -

1. The offer should be valid for minimum 120 days from the opening of price bid.
2. The work is to be executed within 15/30 days.
3. The rates are to be quoted mentioning all taxes, sales tax, service tax/ GST clearly. No post modifications on tax/ Govt. Levy will be allowed/ accepted.
4. The Contract Agreement is to be executed with Department and necessary terms & conditions of the Department are also to be signed by the lowest offerer within 3 days on a non-judicial stamp paper of Rs. 50/-.
5. The job will be guaranteed for six months from the date of completion.
6. A sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with the sum already deposited as earnest money, will amount to Security Deposit of 10% of the tendered value of the work. Bank Guarantee is not to be accepted as Security Deposit.
7. The payment will be released after completion of work.
8. Action will be taken against the firm if the work is not completed within the stipulated period. All deposits of the contractor with the Department will be forfeited pertaining to work.
9. The tender fee will not be reimbursed for any expensed incurred in preparations or submission of tender or for any other reason for the period it remains with the Department.
10. The Bill of Quantity cum Schedule of Quantity, specifications, terms and conditions of the tender will not be used by tendered for any other purpose and will not be given to any other contractor of department or for any other use to any body or agency.
11. The Department (SDMC) reserves the right of reject any of or all the tenders without assigning any reason.
12. The department (SDMC) decision will be final and binding in case of incomplete tenders, cuttings or over writings. Such binding even upto the final stage of the contract.
13. All disputes are Subject of Delhi Jurisdiction only.
14. No conditional tender will be accepted in any way. Tenderers with any conditions including conditional rebate shall be rejected out rightly however tenders with unconditional rebate will be acceptable. No post tender modifications will be allowed/ accepted in any way/ kind.
15. In force major conditions the decision of the Department shall be final and binding.
16. Any type of damage of Govt. / Private properties, accident with the equipment of staff on duty or any person will be borne by contractor.
17. Any accident during upto completion of work will be on contractor's part and department will not in any way compensate for anything.
18. All old material shall be deposited with the department.
19. The contractor will take the equipment for repair in consultation with Engineer-in-Charge of site.
