
The point wise reply of the queries is mentioned hereunder :-

Sl. No	Queries of M/s Rajdeep Publicity Pvt. Ltd.	Reply
1.	On page 4 Cluster No.1 Part B, S. No.3 states that the total units of toilet blocks are 3 nos. whereas on page-5 the total units comes to 4 nos., kindly clarify the same.	It is to clarify that there is 03 nos. of Public Toilets were already existed as street furniture units and 04 nos. of newly constructed Toilet Blocks are added in the Cluster. Thus, there is now total no. of 07 Toilets in the Cluster.
2.	Can we use the display of public toilet by joining them and in one location its purely hidden by FOB (infront of Dhaura Kuan Metro Station). What changes can we make them to be visible and saleable.	No change.
3.	On Dustbin media-who will be responsible to clear the bins on daily basis as the same has not been cleared in your RFP.	It is to clarify that the Department has floated the Tender of Cluster containing Street Furniture items for advertisement rights with maintenance & operation. Therefore, it will be the responsibility of the Allottee to maintain and operate the Street Furniture in good conditions always. Further, the Allottee after cleaning of bins on daily basis may drop the waste/garbage to the nearest Municipal Dhalaw.
4.	Location of free standing panels is not cleared anywhere as where can we can install them.	The point is already clarified in Note - 2 Clause No.3 under heading Eligibility Criteria.
