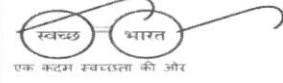

The Online tenders for above subjected work have been invited vide **Tender No.308865**, issued vide No. DDH/ HQ/SDMC/2018-19/D/257/NIT No.6 Dated 08.06.2018. The pre-bid meeting was held on 18.06.2017 at 1500 hours. The pre-bid meeting was attended by the representatives of following firms:

Some queries were raised in pre-bid meeting were explained / replied to the satisfaction of probable bidders and some of them are given as under:

S.NO.	QUERRY	REPLY
1.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The financial bids are to be submitted online only at e-tender portal of SDMC only. The Technical Bids submission has been allowed online as well as manual as per tender document.
2.	The Tender Document states that only 3 bidders will be awarded the Rate Contract. If more than three bidders qualify in the Technical Bids whether the Rate Contract work will be awarded to more than three bidders or not?	If rates received in the financial bids reasonable / competitive, the Department intends to award the Rate Contracts to first three Lowest bidders.
3.	Whether the EMD in the form of FDR & Bank Guarantee will be accepted?	The bid security (EMD) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order only, payable in favour of Commissioner, SDMC payable at New Delhi
4.	Whether the Joint Ventures of Firms is allowed in this tender or not?	Joint Venture of firms has been allowed and Corrigendum-II has been issued in this regard vide No. DDH/ HQ/SDMC/2018-19/355 dated 29.06.18. Please follow the SDMC website in this regard.
5.	Whether the cost of 3 rd party inspection will be borne by the SDMC or not. If the charges are to be paid by contractor, then these will be reimbursed to the contractor or not.	As has already mentioned in tender document at 14.10.3 the Third Party Quality Control Audit check will be got done, by getting the samples tested in any Government or Government designated/ authorised Lab/s. The testing charges on this account will be borne by the contractor. Nothing will be reimbursed to the contractor from SDMC in this regard.
