Open Online tenders from Art Firms which have dealt with catalogued exhibitions / events under single stage two-bid system (Technical & Financial Bid) are invited on behalf of Commissioner, S.D.M.C. for selection of a suitable contractor for this work from interested, experienced and financially sound Firms / Agencies. Joint Venture / Consortium of Art firm with catalogued exhibitions / events with some other firms (for financing purposes) will also be eligible to participate in the tender / RFP. Bidding Documents can be downloaded from the website-<http://mcdetenders.com> The Technical Bids will be opened at **25.03.2019 at 03.30 PM** on website <http://SDMCetenders.com> by SDMC E- Tendering Project Champion. The Technical bid will be received online as well as manual. However, the financial Bids will be received online only at e- tenders portal of SDMC. The registered contractors of MCD (SDMC/NSDM/EDMC) are also eligible to tender for the amount they are registered subject to the condition that they fulfil eligibility requirement in Technical Bid submission. For other contractor(s)/New bidders they may get themselves registered for tendering/bidding in SDMC. 2. After getting themselves registered on e-tender portal of SDMC Eligibility Criteria of Tender for Technical Compliance of the applicant along-with necessary conditions can be downloaded from SDMC website [www.mcdonline.gov.in](http://www.mcdonline.gov.in) / South Delhi Municipal Corporation /Tenders/e-tendering.
3. The Bidder should have sufficient financial turnover Average minimum Rs.703.00 lacs of last three years. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three financial years, should be submitted.
4. **SELECTION PROCESS** A single stage, two-bid system process (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance of each proposal as submitted by the Applicant, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The successful L-1 will be decided on techno - oriented evaluation criteria defined in the tender document.
5. **PERFORMANCE SECURITY** The L-1 firm decided by the department as per evaluation criteria will be considered for award of work. The successful L-1 Bidder will have to submit the requisite interest free Performance Security equivalent to 5% (Five percent)of the amount of contract in the form of Bank Draft/Pay Order/ Bank Guarantee/ FDR in favour of commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 15 days of issue of Letter of Intent/Acceptance from SDMC. Failure in timely submission of required Performance Security the EMD deposited by contractor shall be forfeited to the SDMC and further necessary action for debarring / blacklisting of bidder may be initiated by S.D.M.C.
6. Tender cost of Rs.2000/- (Non refundable) shall be made by way of Demand Draft/Bankers Cheque/ Pay order ONLY. The bid security (EMD) is Rs.28,12,000/- (Rupees Twenty eight lakhs twelve thousand only) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order/Bank Guarantee only. The payments of Tender Cost and Earnest Money should be drawn in favour of **Commissioner, SDMC** payable at New Delhi and may be submitted alongwith Technical Bids documents and will be received in the Office of Dy.
