CORRIGENDUM

To
All prospective bidders

Sub.: Providing multi-facilities service (watch and ward & house-keeping) for Community Halls, SDMC – reply to the pre-bid queries and amendment to the RFP conditions.

With reference to Bid Notice No.964/CSD(HQ)/2014 dated 27.11.2014 and pre-bid Meeting held on 17.12.2014, reply to the pre-bid queries & the amended RFP clauses are as under:-

S.No.	Query	Reply
1.	Number of Supervisors required.	As per page 12 of the RFP, 4+4+4(=12) Supervisors.
2.	Duty Hours for House-keeping.	Single duty & as per need of the hour.
3.	EMD	EMD is required to be deposited as per amended Clause 10 (Page 6) of RFP, given below.
4.	Service Tax	As per RFP.
5.	Payment	The payment will be made on monthly basis as per amended Clause D (Page 19 of RFP) given below.
6.	Security Guards (Watch & Ward.)	Only un-armed semi-skilled for watch and ward are required. A PASARA Act Certificate is also required.
7.	Joint Venture	Not allowed as per RFP.
8.	Extension of time (as per written request)	The bid receipt date is extended to 02.01.2015 at 3.00 PM & opening of technical bids shall be held at 3.15 PM on same day.
9.	Bank Solvency Certificate.	As per RFP.
10..	Last/previous three years.	The last three years shall be taken as 2010-11, 2011-12 & 2012-13 at all places in RFP.

The amendment in the clauses of the RFP are as under:-

(a) Clause 10 (Page 6 of RFP):

The bidders are required to deposit an Earnest Money of **Rs.38 lacs**.The EMD shall be paid in the form of Demand Draft (DD) for a minimum amount of Rs.20 lac in favour of **Commissioner, SDMC** payable at Delhi. The balance amount may be deposited in the form of Bank Guarantee.

(b) Clause D (Page 19 of RFP):

Payment will be made **on monthly basis as per availability of funds** on submission of bills along with all necessary documents viz duly verified attendance sheet by the Incharge of the Community Hall and next superior officer. **The periodical performance shall be duly checked by the SDMC Officers/officials available on site.**

The aforesaid reply to the pre-bid queries and amendment in the RFP conditions shall be considered to be part of the RFP/contract.

It is further reiterated that the bid shall be received upto 3.00 PM on 02.01.2015 and the technical bids shall be opened on the same day at 3.15 PM.
