The South Delhi Municipal Corporation invites sealed tender in two parts (Technical Bid & Financial Bid) for the supply of 10 vehicles to be used as dog vans from the automobile manufacturers / dealers authorized by automobile manufacturing company.

(A). CONDITION OF ELIGIBILITY

Tender documents shall be issued on request to automobile manufacturers / dealers authorized by automobile manufacturing company only. However the eligibility criteria shall be as under.

- The applicant should be an original automobile manufacturer or an authorized dealer of automobile manufacturing company. A certificate in this regard is to be submitted by the bidder.
- The bidder should not be debarred / black listed by any Govt. Organization and an affidavit to this effect should be submitted.
- No extra weight age shall be given for superior specifications quoted over and above the basic specifications. Such offer shall be treated at par with those offers which meet the basic specifications.
- The bidder / Manufacturer should have a service base in Delhi and certificate / documents in this regard are to be submitted with tender documents.

(B) GENERAL INFORMATION

- The tender documents will be issued to the firms on request from the office of the Dy. Director (VS) RCP SDMC, 17th Floor, Dr. SPM Civic Centre, Jawahar Lal Nehru Marg, New Delhi 110002. The tender documents may be collected in person on payment of tender fee i.e. Rs. 500/- in the form of a demand draft issued in favour of the Commissioner South DMC. No tender shall be issued without deposit of the tender fee. The tender document may also be downloaded from the website www.mcdonline.gov.in and be submitted in the office of Dy. Director (VS) RCP SDMC along with the required tender cost.
- The intending bidder shall have to pay an earnest money of Rs. 1.2 lacs in the shape of demand draft of a scheduled bank drawn in favour of the "Commissioner SDMC" at the time of submission of tender.
- Performance security/guarantee: As the vehicles are to be fabricated to be used as dog vans, it shall be the responsibility of the bidder to maintain the warranty/guarantee offered by the manufacturing company for the vehicle even after fabrication/modification as dog van.
- Conditional, incomplete or late received tenders shall not be entertained /considered.
- Bid to be submitted in two parts Technical bid & Price bid VIZ: -

PART-'A'

The technical bid for supply of the vehicles to be used as Dog Vans is to be submitted in a sealed cover duly super scribed as "Technical Bid for Purchase of 10 vehicles to be used as Dog Vans" and it should contain following documents:

1. All the Technical details of the proposed vehicle including the make, model and specification of vehicles.
2. Receipt issued by the department for purchase of tender document or the demand draft of Rs. 500/- issued in favour of the Commissioner SDMC towards the cost of the tender document in case the document has been downloaded from the MCD website.
3. Demand draft of earnest money.
4. Undertaking regarding performance security.
3. All certificates and affidavits as required and mentioned at (A) above.


PART-'B'

The financial bid for the supply shall be kept in another sealed envelope super scribed "**Price bid for Purchase of 10 vehicles to be used as Dog Vans**" as Part B. The rates to be quoted by the bidder in financial bid both in figures and words should be covered by a transparent tape.

The sealed envelope for two bids i.e. Technical Bid & Financial Bids are to be kept in another sealed envelope super scribed as "**Technical bid and Financial bid for Purchase of 10 vehicles to be used as Dog Vans**". The single envelope so prepared is to be submitted in the office of Dy. Director (VS) RCP SDMC at 17th Floor, Dr. SPM Civic Centre, Jawahar Lal Nehru Marg, New Delhi 110002 latest by 3:00 pm. on 10/08/2015.


On the date of tender opening as given in NIT, the main cover (containing technical bid and price bids) will be opened in the presence of bidders who may like to attend. The technical bids shall also be opened at the time. However the time and date of opening of financial bid shall be intimated after evaluation of the technical bids of the eligible bidders through official letter/phone/e mail.

4. In the event of any specified dates for submission or opening of bid is declared a holiday, the bids shall be received/opened, on the next working day at the same place, without any further notice.
5. The rates of bidders should hold good and valid, at least, for a period of 180 days from the date of opening of Price Bid.
6. The South Delhi Municipal Corporation at its sole discretion and without assigning any reason thereof, reserves the right to accept and / or reject, any or all bids. South Delhi Municipal Corporation also does not bind itself to accept the lowest bid.
7. The successful bidder through its proprietor or authorized nominee will have to enter in the Contract-Agreement with the department on prescribed Performa on a non-judicial stamp paper of Rs. 50/-, before placing of supply order.
8. The payment of vehicles shall be made on delivery of vehicles.
9. The offered models should have valid approvals of appropriate authorities. Vehicles should be ready to use in all respects including registration from State Transport Authority, Delhi; after due design approval by the chassis manufacturer.
