MANDATORY EXPERIENCE IN SIMILAR WORK The bidder should have minimum experience of similar nature of works of Construction / Supply & Firing of Cessho / Garden Heat as under.

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.

OR Two similar completed works costing not less than the amount equal to 60% of the estimated cost put to tender.

OR One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender.

AND One completed work of any nature costing not less than the amount equal to 40% of the estimated cost put to tender with zone Central Government Department / State Government Department/ Central Autonomous Body / Central Public Sector undertaking in India. The completion certificate issued from competent authority be submitted along with Technical Bids.

MANDATORY FINANCIAL TURNOVER

Average annual financial turnover of the participants/Contractors/Bidders during the immediate last three consecutive financial years should be not less than the amount equal to 100% of estimated cost put to tender. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three (3) financial years, should be submitted.

PERFORMANCE SECURITY

The successful EA contractor / bidder shall submit Performance security equal to an amount of 10% of the amount of contract in the form of Bank Draft / Pay Order / Bank Guarantee / FDR in favour of Commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 15 days of issue of Letter of Intent /Acceptance from SDMC.

Based on the Technical compliance of each proposal as submitted by the Applicant, financial bids of only eligible bidders shall be considered for opening.

SDMC may disqualify any Applicant/Bidder without notice who submits an incomplete/non-eligible bid. SDMC reserves the right, without any obligation or liability, to accept or reject any or all the proposals at any stage of the process, to cancel or modify the process or any part thereof or to vary any of the terms and conditions at any time, without assigning any reason whatsoever.

Conditions given in the printed NIT Form A-32 Chapter 9 of the Municipal Accounts Code Part I will hold good. The contractor will have to give a declaration about the name of their relatives employed in SDMC along with each tender. Deduction of Income Tax, VAT, Labour Cess etc. at source shall be made as per rates.
