**MANDATORY EXPERIENCE IN SIMILAR WORK** Experience of having successfully completed similar works during the last 7 years ending last day of the month previous to the one in which applications are invited. The bidder should have minimum experience of similar nature of works i.e. "Construction / Supply & Fixing of Gazebo / Garden Hut" as under.  
Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender. OR  
Two similar completed works costing not less than the amount equal to 60% of the estimated cost put to tender. OR  
One similar completed work of aggregate cost not less than the amount equal to 80% of estimated cost put to tender. AND One completed work of any nature costing not less than the amount equal to 40% of the estimated cost put to tender with some Central Government Department / State Government Department/ Central Autonomous Body / Central Public Sector undertaking in India. The completion certificate issued from competent authority be submitted along-with Technical Bids.

**MANDATORY FINANCIAL TURNOVER**  
Average annual financial turnover of the participants/Contractors/Bidders during the immediate last three consecutive financial years should be not less than the amount equal to 100% of estimated cost put to tender. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three (3) financial years, should be submitted.

**PERFORMANCE SECURITY**  
The successful L-1 contractor / bidder shall submit Performance security equal to an amount of 5% of the amount of contract in the form of Bank Draft / Pay Order / Bank Guarantee / FDR in favour of Commissioner, SDMC payable at New Delhi.
