Term & Condition :-

- All terms Conditions given in the printed NIT from A-32, Chapter 9 of the Municipal Accounts Code Part I will hold good.
- The contractors will have to give a declaration about the name of their relatives employed in MCD along with each tender.
- Bidding Documents can be downloaded from the website-<http://mcdtenders.com>.
- Both Tender cost and Earnest money can be deposited in the form of Bank Draft of a scheduled Bank in favour of commissioner, South Delhi Municipal Corporation.
- The desirous contractor's shall have to Pay the Tender Cost and Earnest Money mentioned against the work at the time of download of tender documents and the same has to be deposited at the time of Re-encryption of online bid and same will be received in the office of Ex. Engineer (Elect)-IV.
- VAT (Value-Added Tax) @ 4/6 % VAT will be deducted at the time of making payment to the contractor/ at the time of crediting such an amount to the account of the contractor, whichever is earlier.
- If the rate quoted by the lowest tenderer are found abnormally low the payment to the contractor for the work shall only be made after inspection by the Quality Control cell at different stages and these finding shall be final and binding on the Contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case, the lowest contractor fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enlistment rule / instruction issued from time to time.
- Labour cess @ 1% will be deducted from all Bills / Payments of contractor in compliance of the Building and Construction Worker Welfare Cess Act. & Rules 1996.
- All other standard terms & conditions mentioned will be applicable & bind able to all contractors.
- Detailed N.I.T. can be seen in the office of the undersigned. Ex. Engineer (Elect)-IV
- Circular Vide No.04/EE(P)-JSDMC/2014-15 DATED 08.04.2015 & Circular Vide No.SE(O)/SDMC/EE(O)/JSDMC/2015-16/D-1020 DATED 29.07.2015 regarding third party quality assurance will be applicable and charges for the 3rd Party quality assurance is to be borne by the contractor.
- In case of abnormally high rates, the executed quantity shall be kept within the BOQ quantity and in case of abnormally low rates, it will be ensure that the executed quantity will be at least equal to the BOQ quantity. However in the instant of quantity executed for the abnormally high rate item is higher than the BOQ quantity, the payment for the quantity executed above the BOQ quantity will be made on justified rates. Similarly in the instant of quantity executed for the abnormally low rate item is lower than the BOQ quantity, the recovery for the quantity executed below the BOQ quantity will be made on justified rates.
- The bidders should comply the statutory provisions including provisions of EPF & MP Act 1952.
- The bidders should be registered with EPFO & will submit the proof along with the demand draft of Earnest Money & Tender Cost.
- Before admitting any claim the bidder has to submit the proof of depositing the due EPF contribution in respect of workers/employees deployed for instant proposals with EPFO.
- All circular issued by MCD from time to time is applicable.
